

Regulation (EU) No 2019/1148 on the marketing and use of explosives precursors, applicable from 1. February 2021:

Dear seller of Substral products,

We kindly ask you to take note of the information below and to implement it in your company.

Plants need the right nutrients to grow well. Fertilizers are products tailored to the specific needs of the plant which are offered to consumers in different combinations and with a variety of raw materials. Although the products are subject to strict requirements of the EU Fertilizing Product Regulation and are therefore safe in use, they may pose a risk if certain raw materials are misused. For example those precursors referred to in Regulation (EU) 2019/1148 may be misused for the illegal manufacture of explosives for criminal, in particular terrorist, purposes.

Thus Regulation (EU) 2019/1148, applicable from 1 February 2021, introduces new obligations regarding the marketing and use of explosives precursors. The new regulation:

- specifies the definition of "regulated explosives precursors" (article 3), namely: "a substance listed in Annex I or II, including a mixture or another substance in which a substance listed in these annexes is present, excluding homogeneous mixtures of more than five ingredients, in which the concentration of each substance listed in Annex I or II is less than 1% w / w ". Thus, all products containing an explosive precursor in quantities of 1% or more will be affected. -even if they are in complex mixtures,
- completes the list of substances affected by the obligations of this Regulation (Annexes I and II) as well as the associated limit values,
- introduces the following obligations:
 - **to share information in the supply chain** (Article 7), namely: "any economic operator who places a product subject to restrictions under the regulation to the provision of another economic operator is required to inform it."
 - to report any suspicious transaction and significant disappearance or theft within 24 hours to a national contact point (article 9)
 - **to put in place appropriate, reasonable and proportionate procedures** to detect suspicious transactions (Article 9)

You will therefore find in Annex 1 the current list of products which were supplied in the past by Evergreen Garden Care containing one or more **EXPLOSIVE PRECURSORS TO BE SUBJECT OF A REPORTING**: "substances as such, or present in mixtures or substances, about which suspicious transactions as well as significant disappearances and significant thefts must be reported within 24 hours".

We kindly ask you as a downstream trading company to note your reporting obligation in accordance with Article 9.

Please pass on the information about affected products within the supply chain to downstream trading companies if necessary. Please note that the obligation to report applies to all persons regardless of whether they are members of the general public, commercial users or economic operators.

We have ensured that all products we currently offer do not fall under this regulation. However in case you still stock older products listed in the Annex 1, we would like to assure you that all products listed in the attachment are complex NPK fertilizers consisting of several raw materials which are offered to consumers in small packages. Thus, as such, these products do not present a danger or explosive risk. All products are safe to sell and to use. As before, they can be sold to consumers without restriction.

However, since they contain one or more explosive precursors, surveillance will have to be put in place according to the terms of the regulation in order to identify and prevent in good time suspected cases of illegal use.
